# **Area Office changes –** Edinburgh, Birmingham and London

Our network of test centres are supported administratively by five area offices. By April next year we will move to a new structure where test centres are supported by two area offices: based in Newcastle and Cardiff. The area offices in Edinburgh, Birmingham and London will close.

The Newcastle and Cardiff area offices will become centres of excellence for customer services including the bookings of driving tests and general enquiries.

There will be no change to test centres or how driving and riding tests are delivered to customers. Chief Executive, Rosemary Thew, said: "This restructuring will enable us to focus more activity on driver safety issues while providing a more effective service to our customers."



### **Criminal Record** checks for ADIs

We have been speaking to the ADI industry about implementation of criminal history checking.

The first check will be when an application is submitted to start the qualifying process. It is likely that we will ask most new applicants to apply directly for a criminal record check, which they will attach to their ADI3 form when they send it to us.

We are aiming to introduce the checks of new applicants at the end of February 2007, and the checks of existing ADIs as soon as possible after that date. Checks of ADIs who are renewing will probably begin about six months later. Final details of the procedures will be available on our website as soon as they are confirmed and we will put some more information in the next edition of Despatch.

Having a criminal record will not necessarily result in an automatic ban on being a driving instructor. We intend to comply with the CRB's and Disclosure Scotland's Codes of Practice that certain factors should be taken into account when assessing if someone is suitable for the job.

Strict rules apply to the use of the checks and how data is stored, which include that they must not be retained for longer than is necessary. Also, we are not permitted to record anywhere any details of the offences, and photocopies must not be retained. Information will not be passed to a third party.

# HPT – There's Still Time – **Book Today** on 0870 01 01 372

The deadline for existing ADIs to meet the standard in the Hazard Perception Test (HPT) is now very close.

The Registrar, Charles Morton, wrote to all ADIs who had yet to pass the test in June and November. Both times this led to a rush of test bookings and this could happen again this month. We would urge any ADIs yet to take the assessment not to leave it another minute. Those who have not passed the test by the deadline of 31 December, should expect to have removal proceedings against them.

Some of you may not need another test if you passed HPT with a score of 57 or more as part of another DSA theory test, eq

driving examiner recruitment. However, we will not be automatically aware of your success, so please urgently send your original results sheet to us at the ADI section, DSA, Stanley House, 56 Talbot Street, Nottingham NG1 5GU. Provided we can confirm your test pass and score, you would not need to repeat the assessment. Also, please contact us if you have passed the assessment but not received a certificate showing your success so that we can be sure your records are correct.

# Consultation paper: Service improvements, safety related measures & general fee increases

On 19 October we published a Consultation Paper which looked for views on a package of measures to change the way we conduct our business to deliver a better service, improve the quality of the assessments we offer, and to ensure that the costs of the services provided are recovered fairly and efficiently.

The proposals are grouped into three areas:

- Service improvements
- Safety related measures
- General fee increases

We wrote to over 4, 000 individuals and organisations to announce the start of the consultation and an e-copy of Despatch Express was sent to 20,000 of you who registered for news through our website (see "My DSA").

# Changes to the vehicles used for driving tests

In October 2003 we introduced a number of changes to the minimum standards for vehicles used for driving tests.

People who had already invested in new vehicles before October 2003 were allowed a period of time before having to upgrade their vehicles to meet the higher standards. That grace period runs out on 1 July 2007, when all vehicles used for driving tests will be required to meet the higher standards. For further details, please visit www.dsa.gov.uk.

# Seatbelts for examiners conducting PCV driving tests

This is a reminder that from 1 July 2007 all buses, coaches and minibuses used as test vehicles will be required to have either a two or three point seatbelt fitted for use by the driving examiner during the test. This is to comply with health and safety recommendations.

## Road Safety Bill - an update

Many of you are already aware that the Road Safety Bill has completed its Parliamentary process and has received Royal Assent to become the Road Safety Act 2006. In the short term however, this will have no impact on the existing Approved Driving Instructor qualification and registration arrangements.

The Act will, amongst other things, enable new mandatory quality assurance arrangements to be introduced for a wide variety of persons and businesses that give driving instruction, including existing ADIs. The new arrangements will enable DSA to introduce improved qualification processes for those seeking to become ADIs.

Although the Act specifically anticipates the abolition of the existing trainee licence scheme, the replacement arrangements will continue to provide the opportunity for people to give paid instruction as part of a structured qualification process.

Replacement of the existing arrangements for ADIs will be a major task, for DSA and other key stakeholders, so it certainly won't be introduced overnight. We need to consult extensively with interested parties before making any recommendations to Ministers. It is highly unlikely, therefore, that any replacement arrangements could be introduced before 2008 at the earliest.

Meanwhile, the trainee licence scheme will continue.

# Business Customer Conferences

This year we have held seven successful Business Customer Conferences where Approved Driving Instructors, Approved Motorcycle Training Bodies and Large Goods Vehicle Instructors attended to find out the latest news on national issues affecting their working lives, and met with DSA's senior team and experts.

According to the feedback from the survey conducted at the end of every conference, the majority of delegates' needs and expectations were met during the events. 96% would attend a similar event and would recommend others to attend.

The next conference will be held on the 17 January 2007 in the Leeds/Bradford area. We hope to hold more events around the country during 2007.



## Motability Scheme

# PASS PLUS training for Young Drivers

Motability, the leading car scheme for disabled people, recently launched an initiative to arrange and fund PASS PLUS training for young drivers of its 415,000 contract hire cars. The DSAdesigned PASS PLUS course was chosen as the tool to help Motability encourage safer driving and reduce the rate of accidents and insurance claims because of its established name in the market. Motability's programme was developed in partnership with the AA and the scheme's fleet insurer, Royal & SunAlliance Motability. It was recently highly commended in the "Road Safety in the Community" category of the road safety charity Brake's Fleet Safety Forum awards.

Royal & SunAlliance Motability recognise successful completion of the PASS PLUS course through a lower excess payable in the event of a claim.



So far over 1300 drivers have registered for the course, with 300 successfully completing it already. Motability ultimately hope to fund training for around 6000 drivers per year once the initiative is fully established. They're very pleased with the positive feedback from drivers, with quotes such as "worked a treat", "real confidence booster" and "fantastic – I'd jump around the room if I could".



### Pass Plus letters for new drivers

To help Pass Plus instructors to promote their services, we are now sending a letter to all successful car practical test candidates explaining the benefits of the Pass Plus scheme. The trial started on 6th September and will last for 6 months. The aim is to remind newly qualified drivers about Pass Plus when they may be most likely to start the programme.

# Opening of first Multi Purpose Test Centre

Dr Stephen Ladyman, Minister for Transport, opened the first Multi-Purpose Driving Test Centre (MPTC) at Gloucester on 19 October.

Rosemary Thew, examiners, local ADIs, motorcycle trainers, representatives from the motorcycle industry and road safety organisations, were also present to mark the opening. There was also a demonstration on the off-road area of the forthcoming motorcycle manoeuvres for the 2008 test.

The Gloucester MPTC is the first of a network to be introduced across Britain from which the new motorcycle test will be conducted.

The test has been introduced to comply with European legislation aimed at improving the standard of road safety for motorcycle and moped riders. These user groups have been identified as having a high risk of injury or death; particularly the case for young and inexperienced riders.

Stephen Ladyman said; "In 2004 alone 25 641 bikers were involved in accidents; 585 were fatal. Although accident numbers are falling there are still far too many, which is why the DSA's new centres are so important."

Rosemary Thew, added "The new centres are key to road safety and fit into our overall vision of 'Safe driving for life'. We hope that local communities will recognise the important role of the centres in supporting road safety."

Most of the new test centres will also provide car testing facilities for the area and in a few cases additional Large Goods Vehicle (LGV) / Passenger Carrying Vehicle (PCV) testing facilities where capacity does not currently meet demand.

# Update on **Driver CPC**

#### **Initial Qualification**

When Driver CPC is introduced in 2008 for new bus drivers, and 2009 for new lorry drivers, those coming forward for their vocational test can also take their CPC initial qualification at the same time.

This will consist of 4 hours of theory testing including a new case studies element, and 2 hours of practical testing with an additional 1/2 hour practical demonstration of safetyrelated issues. Work is currently underway to develop the case studies and the practical demonstration.

The tests will be in a modular format and integrate the current licence acquisition tests:

#### **Transition Arrangements**

To reduce the impact of the move to a 21/2 hour theory test, we are consulting on plans to increase the number of questions in stages: from 35 to 60 items from April 2007, and to 100 items in April 2008.

#### **Periodic Training**

The process for the approval of training providers and training courses is being developed in partnership with the Sector Skills Councils for the two industries. Only training taken with approved organisations and on approved courses will count towards the 35 hours of periodic training a driver must complete every 5 years.

Red Scientific will undertake mystery shopping exercises to quality assure the standards of service delivered by our telephone booking and enquiry lines and our on-line booking systems. IPSOS MORI will undertake a range of qualitative research activities, such as focus groups and

workshops as well as quantitative surveys, including telephone surveys of candidates and PDIs and postal surveys of ADIs, ATBs, ORDIT trainers and LGV instructors.

# DSA looks to the future

At DSA we need to be thinking longterm if we are to stay at the forefront of the best services for supporting competent, safe drivers. We need to not only consider our responsibilities for testing drivers, but also how we can influence and help drivers to drive safely throughout their life.

DSA's new Safe Driving Strategy team has started to look at developments in technology, changing policies, international best practice, and new research. It also aims to build relationships with partner bodies who are interested in developing and delivering road safety.

We set up a series of workshops for partners at the end of October and conducted one-to-one interviews with other key stakeholders to ensure that we captured all the key views. We are now looking at how we can use the results of those workshops to shape our thinking about DSA's future direction.

We have also tasked the Transport Research Laboratory with undertaking a review of the practical and theory tests. This review will build on existing research to establish the validity of the current test and explore ways in which it might change. Work is under way and we expect the first report in December.

### **Agency Performance** April - October 06

At the end of September we forecast that we are on track to achieve all of the Secretary of State targets.

Progress to the end of October is as follows:

- Appointments will be available within nine weeks at 90% of permanent car driving test centres: 99%
- In order to provide off road motorcycle test facilities to comply with EU requirements to have 20 multi purpose test centres operational by 31 March 2007: 3
- To achieve candidate satisfaction with the overall service received at 90% or better: Not yet available
- Improve standards of professional lorry and bus drivers - to have accredited 10 training courses as being suitable for bus

- & coach drivers CPC periodic training by March 2007: 0
- Improve driving standards of new drivers
   Deliver Arrive Alive presentations to
   165,000 people by March 2007: 57,692
- Improve driving standards of new drivers
   Issue 120,000 Pass Plus certificates by March 2007: 65,926
- Improve driving standards of existing drivers - Deliver Arrive Alive Classic presentations to 15,000 people by March 2007: 3,365
- In order to raise the standards of tuition and to prevent unqualified ADIs giving instruction to learner drivers, from January 2007 remove ADIs from the Register who failed to pass the HPT by 31 December 2006: 86.7% have passed, leaving 5,419 yet to pass

John Reynolds, British Superbike Champion in 2004, affiliated to the Think! campaign, and who helped us to launch new elements to our Arrive Alive scheme last year, has again introduced Ride On. John has appealed for young riders to enjoy motorcycling, but to save racing for the track.

For 2007 we have also attached a safe motorcycling DVD, produced by the Highways Agency, to the first 30,000 Ride On magazines. The DVD was scripted and produced with DSA input.

# Fitness to drive

Dr Tim Carter, Chief Medical Adviser at the Department for Transport has written Fitness to Drive: A Guide for Health Professionals - an essential resource for



all health professionals to help them give valid advice on fitness to drive.

Although the book is written primarily for health professionals it is also aimed at providing valuable information to others

concerned with health and fitness to drive, including road safety advisors, insurers, fleet managers and driving instructors. Drivers with health problems who want to understand the relevance of their condition to driving and how it may be assessed could also find this book useful.




# DSA in women's top 50

# **DSA Motorcycling** Update

We announced the introduction of a voluntary quality assurance scheme for post-test motorcycle training at the Motorcycle show in October. This scheme is aimed at trainers who are providing services to full motorcycle licence holders who have recently passed their test, are looking to upgrade their riding skills or who are returning to motorcycling after a break. In consultation with the motorcycle industry, we have identified competences and skill sets for the trainers and are developing the arrangements for entry to the DSA scheme.

Once the scheme is established we will ask the Pass Plus Board to consider extending Pass Plus to cover motorcycles.

Pre-test training and Direct Access Scheme (DAS) research continues with visits to approximately 150

Approved Training Bodies (ATBs) nationally. We would like to thank the ATBs who volunteered to take part in this important review. Once the review is complete, the results will be analysed in association with independent research undertaken by the Transport Research Laboratory. This research will also be used to inform a review of Compulsory Basic Training (CBT) with the aim of delivering better CBT in the future

We are currently working in partnership with motorcycle training industry representatives on the production of a DVD 'Ultimate Biking' which will cover all aspects of motorcycling from CBT to posttest, track to open road.

We will continue to give greater focus to the requirement for all drivers to recognise and look out for motorcyclists by the development of the Hazard Perception Test.

Earlier this year we appointed five regional CBT Managers. They will shortly be joined by four Deputy CBT Managers and together they will work full time on the quality assurance of motorcycle training and testing.
